## Initiative Summary:

The initiative is an inclusive and Pan-Nigeria learning hackathon and industry seminar focused on solving specific local problems and driving data-driven decision making in the Energy sector with broad-based social and business impact. The event is aimed at building an ecosystem for local talent development and sectoral application in Energy with the broader objective of:

- Increasing employability of young Nigerians through hands-on exposure to data science in a real-world capacity
- Building solution-orientation where theories are applied and deployed
- Enhancing quality of machine learning skill set available in the country, while deepening local content agenda
- To drive real-world application that solves specific business problems whilst finding an intersection between theory and practice.

**Theme:** AI for Energy - Carbon Reduction

**Hackathon focus:** Developing Artificial Intelligence Solutions for Carbon Reduction in the Energy Sector.



## Intellectual Property Rights, Guarantees and Release of Responsibilities

Intellectual property rights, guarantees, release of responsibility and assignment of intellectual and moral rights, by participating in the hackathon and accepting the Terms and Conditions, each Participant hereby:

- Agrees with effect from the commencement of the hackathon to irrevocably transfer and fully assign: a) all Intellectual Property Rights together with all right, title, ownership and/or interest; and b) any and all Moral Rights in ideas, content or product to Data Science Nigeria and the Sponsor. No additional consideration shall be payable to you or any third party by Data Science Nigeria and the Sponsor in respect of such transfer of Intellectual Property Rights;
- Agrees to reasonably assist Data Science Nigeria and the Sponsor in registering such rights of ownership and Intellectual Property Rights as required by law (e.g. filing of patents and other such registrations as appropriate); and;
- Agrees to indemnify Data Science Nigeria and the Sponsor (its representatives, employees, assignees) and to hold it harmless against any loss, liability, damage or expense suffered or incurred as a result of breach of this clause.

*Intellectual Property Rights shall include, without limitation, any ideas, concepts, know-how, data processing techniques, copyrights, patents, designs, inventions, trade secrets, software, source code and documentation, notes, memorandum and any other intellectual property rights attaching to MVP and MVP Content created, invented and/or developed by you and/or alongside other Participants pursuant to participation in the AI for Energy hackathon.*

*Moral rights mean any and all rights of authorship including accreditation and control relating to future use or dissemination of MVP and/or MVP Content.*



## Instructions and Behaviours

Participants agree to observe the following simple rules of conduct:

- Respect the host/facilitators and other participants
- Do not use expressions that incite violence or forms of discrimination, obscenity, or defamation
- Avoid content or comment that is offensive, vulgar, defamatory, or that violates privacy or is otherwise against applicable law, as well as advertising content or content that concerns political or religious views or other such ideologies
- Avoid comments or inputs that are clearly off topic compared to the assigned task or challenge;
- Use your real name and not nicknames or pet names.

## Privacy and Data Protection

- The Participants hereby agree and acknowledge that any photos, videos and/or other recordings taken during the hackathon can and will be used by Data Science Nigeria and the Sponsor, and that Data Science Nigeria and the Sponsor shall have a perpetual, irrevocable, sub-licensable, transferable right to copy, use, display and publish the photos, any videotaped, photographed, and/or recorded materials in which you appear in any online, electronic and/or print format (including but not limited any social media sites or platforms) for any educational and/or promotional purposes of Data Science Nigeria and/or its Hackathon vendors, contractors, content partners and/or sponsors.
